COMPULSORY ACQUISITION OF LAND AND RIGHTS OVER LAND

Irish Water Compulsory Purchase (Greater Dublin Drainage Project) Order, 2018 dated 18th June 2018

An Bord Pleanála, has, on the 11th day of November 2019, made a Confirmation Order (“the Confirmation Order”) confirming (with modifications) the above-named Compulsory Purchase Order (“the Order”) as respects the land and rights over land described in the Schedule hereto. The Order, as so confirmed, authorises Irish Water (hereinafter referred to as “the Company”) to acquire the said land and rights over land compulsorily for the purposes of the Water Services Acts, 2007 to 2013 and of the Greater Dublin Drainage Project.

The Order, as so confirmed, will become operative three weeks from the date of publication of this Notice.
